The Airport Authority Board wields the ability to impose more property taxes upon the city of Lincoln but hasn't and so people have not worried about the level of accountability and transparency.
Jim Lauerman	The board meetings are open to the public. Media covers the meetings. The City of LNK supervises financial transactions.
Tai R. Pleasant	I would recommend that the board takes full responsibility for anything that happens at the airport.

John L. Hoppe, Jr.	We follow all laws and regulations that the federal government put on us. Not much to recommend!
