Abortion/capital punishment/etc. - What definition do you give for each of these terms: pro-life, pro-choice? How do you define yourself and how did you arrive at that view? How does your position relate to the death penalty, embryonic stem cell research, and physician-assisted suicide?

Joseph Hering

Personally, I would not choose abortion if a woman was carrying a child of mine; however as it did happen in my past, a woman did not want to carry a child of mine and aborted it. As much pain as I felt at that, it is a woman's right to choose. Taking a public administrators role and viewing generational poverty and demographic considerations the lesser of the costs leans towards pro choice. My stance as being pro capital punishment is not related, in my mind, to my stance on women's reproductive rights. Moral considerations in the realm of reproductive rights are a part of individual belief, but in administering the public affairs regarding capital punishment different considerations must be given greater credence. As a civilized society we must have rules and punishments and the ultimate punishment is fit for ultimate crimes, plus it is less costly and less vindictive to remove a person who has earned the death penalty, by their own actions, from society rather than to let them live on. Euthanasia is also separate as it is more humane than allowing a person to waste away in a medicated haze until their organs give out, as I have seen many times with family members that have lost their battles with cancer. There is a point of no return when even if a cure was found a person's organs are to far gone to come back and it would be more humane to allow a person to pass with dignity. Having a set of guidelines regarding euthanasia is, in my eves, is another hallmark of a civilized society.

Greg Hosch	I consider myself to be pro life. I support the current state laws concerning Stem Cell Research.
Merv Riepe	I am prolife but support the death penalty for those that create heinous crimes.

Homosexuality - Some consider same-sex relationships should carry the same rights and privileges as traditional marriage. Some view homosexuality as an issue of potential discrimination on the level with race or ethnicity. Some consider it a matter of personal privacy. Some say marriage, for numerous reasons, should remain defined by government as between one man and one woman. Some say children should be raised by a mother and a father and that they are being forgotten in today's discussions on the subject. With which group's philosophy do you most closely agree, and why?
