Utilizing natural resources wisely is a good thing, and we want a pristine environment in Nebraska. But the federal government, apparently aligned with the U.N., has increasingly gone after American agriculture and industry in unreasonable ways that are not designed to reach legitimate and appropriate objectives. The Attorney General must stand up for Nebraskans where federal government agencies, such as the EPA, overreach legal boundaries.

<u>Death Penalty</u> - In your opinion, could the death penalty be a deterrent to crime? How or why not?

Brian Buescher	I believe the death penalty can be a deterrent to crime. A person in Nebraska knows that the death penalty is a potential punishment for crimes committed here.
Mike Hilgers	Yes, it can. Punishments are deterrents; the ultimate punishment can also deter certain crimes.
Doug Peterson	I do believe the death penalty "could" be a deterrent to an individual committing a crime, however, I believe the death penalty's primary purpose is to serve as a measured punishment based upon heinous and capital acts.
Pete Pirsch	Yes, the death penalty is a deterrent to certain murders that would otherwise occur. Many reputable studies have concluded this.

Mike Hilgers	Like all relationships, it is important to build strong lines of communications, trust, and respect. The only way to do that is through constant, genuine effort. I am eager to help build those relationships.
Doug Peterson	As an Attorney General, to enhance the relationship with international and multi-ethnic communities, I think it would be important to meet the leaders of those communities and let them know the importance and priority the Attorney General's office has in working with law enforcement agencies and County Attorneys to provide strong law enforcement in the communities and make sure you have "the buy-in" of those community leaders.

Doug Peterson	Two immediate educational needs in fighting the drug problem is making young people aware of the high THC factors in marijuana
2008.0000	coming out of Colorado so they know the dangers associated with that. Secondly, teen abuse of pharmaceutical drugs needs to be addressed by a better coalition between pharmacists, prescribing physicians, and law enforcement.
Pete Pirsch	The Attorney General can continue to educate, via the media and in other forums, Nebraskans and the legislature regarding the greatest threats posed by drugs. My unique background in the legislature, which includes working on issues of prescription drug
	abuse, poisonous synthetic marijuana such as K2, methamphetamine production, forfeiture law, and many other drug-related issues,

Brian Buescher

As Attorney General, I will take immediate action to work with our state legislators to introduce legislation which eliminates "good time" sentence reductions for repeat, violent offenders. As a former domestic violence prosecutor, I prosecuted several defendants with pages and pages of convictions and arrests for violent offenses. Many of these violent offenders were entitled to receive "good time" reductions on their sentences under the "good time" law. This must stop. I believe the "good time" law should be changed so that offenders who repeatedly commit violent offenses are not eligible for "good time" at all, and instead are required to serve their entire sentences. I believe that faith-based outreach into our justice system is an effective outreach tool, but only if individuals incarcerated welcome the opportunity. I have seen the results of such outreach, such as Victory Boxing Club in South Omaha. I do believe that we should work toward a system that results individuals having more certainty that they will be punished if they violate the law. I believe this will reduce crime. I do believe that mandatory minimums can be an effective deterrent; however, our prison system is also overburdened. I believe that we should look at reforms such as monitoring systems and additional intensive probation options for non-violent criminals to ease prison overcrowding.

Mike Hilgers Doug Peterson

Among other things: I do believe we ought to reform our good time system to more of an earned time system.

I believe everyone agrees that good time laws reducing a person's sentence must be based upon actual good time, and the individual's efforts to take advantage of rehab and educational programs offered within the prison system. I believe the faith-based solutions have developed a proven track record of better preparing inmates, upon their discharge, to have a more successful and productive life. There are several good models showing that the faith-based organizations have been effective.

Pete Pirsch

"Good time" laws should be changed to "earned time" laws in Nebraska. Violent offenders who persist in violence should not automatically receive half their sentence eliminated. They should have to earn any sentence reduction with good behavior. I am a cosponsor of the bill in the legislature that would make that change.

Gambling - Discuss the pros and cons of government having more revenue from gambling.

Brian	While some would say that casino gambling can offer increased tax revenue to the state, I feel that legalizing casino gambling in our
Buescher	state would have little overall positive benefit and would be far outweighed by the negative impacts.
Mike Hilgers	I do not support expanded gambling. The government ought to handle its spending problem by reducing spending.
Doug Peterson	I oppose the government receiving more revenue from gambling. The cons of government deriving revenue from gambling are that such gambling attracts other criminal activities, it is a poor excuse for a government not properly managing its costs, and it can play into certain individual's vices.
Pete Pirsch	As with any new revenue source, the government is wasteful in its spending practices. Overall societal costs may be very hard to predict, and may be significant.

<u>Underage drinking</u> - What needs to be done to curb underage drinking?

Brian Buescher	I believe that we must do a better job of educating young people of the dangers of underage drinking. I also believe that we need to do
	a better job of enforcing the laws regarding underage drinking, as I believe more certainty in punishment would deter those under 21

years from drinking illegally.

Mike Hilgers

Among other things: education, strong parenting, and enforcement of penalties.

Doug Peterson

Educational programs in junior high school and high school that show the physical effects of alcohol, but also show a real picture of the damage and consequences caused by youth drinking, which would include tragic accidents, the consequences of an arrest record, and other detrimental effects commonly caused by intoxicated youths. Strong law enforcement in underage drinking is also needed.

Pete Pirsch Underage drinking can be deadly. Parents need to be involved in the lives of their children and have good communication with the children about the dangers present with drinking while being underage. Underage violators need to have swift and appropriately significant consequences.

Crime - What community involvement activities would you recommend to combat crime?

Brian Buescher	I believe that outreach and building effective community coalitions is one of the most effective ways to reduce crime. This is most readily obvious in the neighborhood watch organizations throughout our state.
Mike Hilgers	[not answered]
Doug Peterson	Communities taking over ownership of the neighborhoods with the "broken windows" mentality are important. Law enforcement will need to work closely with those community leaders in order to provide protection. Ultimately, the community decides whether or not it is going to maintain safe streets or let them be run by hoodlums.
Pete Pirsch	I think families, churches and neighbors, in partnership with law enforcement, need to play stronger roles in ensuring their communities are safe and free from crime. From sponsoring community safety forums, neighborhood watches, healthy after school events, and promoting mentorships, communities can play a key role in preventing problematic crime.

Brian Buescher	The United States Constitution, the Constitution for the State of Nebraska, and State and Federal Statutes and Regulations.
Mike Hilgers	The U.S. and Nebraska Constitutions, and the Nebraska Revised Statutes are the primary governing documents.
Doug Peterson	The United States Constitution, the Nebraska Constitution, and all Nebraska statutes passed by the Nebraska Legislature.
Pete Pirsch	The Constitutions of the United States of America and of the State of Nebraska, as well as federal and state law, are the major governing documents for the Attorney General position.

<u>Personal Story</u> - Please briefly describe a situation where you had to stand alone for what you thought was right when the momentum was pushing the other way. What was the result?

Brian Buescher I have represented several clients against federal government intrusion and regulation in a variety of different matters. In several circumstances, it appeared very difficult to convince the United States government to back down from its often overreaching initial position. Despite this, I have been able to convince federal authorities to back down to some extent or refrain from further enforcement actions. The result was a more fair result to my client.

Recently, at a meet and greet event, one of those in attendance asked "when is Nebraska going to wake up and allow for same sex marriage?" I wasn't sure where this audience of approximately 25 stood on this issue, but based upon my faith in Christ, I told them I did not think it was a matter that Nebraska needed to 'wake up' on. I told them that we passed a Constitutional Amendment in 2000 to uphold that in Nebraska a marriage is only between a man and a woman. I told them I believe in those values and I am not impressed by those states who seem to think they are superior to us simply because they allow same sex marriage. The room was quiet for a while, but after the event I met others who affirmed my position.

In the legislature last year, we discovered late in the 2013 session that state government collected an additional \$50 million in taxes from Nebraskans that we did not anticipate collecting. No legislator could articulate a present governmental need for the money. But many legislators argued that the legislature should keep the money anyway, essentially arguing that the taxpayers would be none the wiser if we kept it. I determined to step up to the plate for the taxpayers of Nebraska, and I offered an amendment to send the money back to the taxpayers. I lead the effort to do so on the floor of the legislature, despite overwhelming opposition. I am proud to have stood up for what is right.

Brian Buescher	I am pro-life and believe an unborn baby is a unique human being. I refer the reader to the survey I provided Nebraska Right to Life which will be made public and addresses all of the referenced issues.
Mike Hilgers	I am pro-life. I do not support repeal of the death penalty. I am opposed to physician-assisted suicide.
Doug Peterson	I believe that life is created at conception and beginning at that time it deserves protection. I have worked in the pro-life movement, having served on the Board of the Lincoln Crisis Pregnancy Center, and have chaired that Board for the last three years. I do believe it is necessary to have the death penalty used on limited occasions based upon the current enhancement factors that we have in the Nebraska statute. I am against embryonic stem cell research because there are more positive signs seen in adult stem cell research and you would never want to create an industry in which embryonic stem cells were being produced and used for medical purposes. I do not believe in physician-assisted suicide. It is a complete conflict of interest to the physician's oath. God is the giver and taker of life.
Pete Pirsch	Pro-Life includes the belief that life starts at the time of conception. I have always been Pro-Life, and as I have witnessed the daily development of my own children from the earliest stages of pregnancy, my Pro-Life beliefs are re-confirmed. I support the death penalty because it serves as a deterrent to the murder of innocent human life. Human life should not be destroyed for scientific research purposes, and I do not support physician-assisted suicide.

Homosexuality - Some consider same-sex relationships should carry the same rights and privileges as traditional marriage. Some view homosexuality as an issue of potential discrimination on the level with race or ethnicity. Some consider it a matter of personal privacy. Some say marriage, for numerous reasons, should remain defined by government as between one man and one woman. Some say children should be raised by a mother and a father and that they are being forgotten in today's discussions on the subject. With which group's philosophy do you most closely agree, and why?

Brian Buescher I believe marriage is a union between a man and a woman. I do not believe homosexuality should be considered the same way race or ethnicity is considered with regard to anti-discrimination laws which currently apply to race or ethnicity. I also believe all citizens of our nation deserve the right to life, liberty, and the pursuit of happiness.

Mike Hilgers The family is the bedrock unit of society. Family breakdown imposes great costs on society. Government has a role in protecting and strengthening the institution of marriage. I believe that history has shown that the traditional definition of marriage is the best vehicle for building strong, stable, families.

Doug Peterson The history of civilization, the knowledge of science, and common sense, all dictate that for a society to sustain itself, the only purposeful recognition by government of a family relationship is that relationship between a man and a woman. If government thought it was necessary to broaden that definition it would significantly effect a society's ability to sustain itself, and would bring government into the most personal part of an individual's life, their sexuality, and create it as part of their identity to be known publically. It is ridiculous to suggest that government now has to identify the 42 different recognized sexual orientations, or individually perceived orientation and conclude that they are all worthy of protection. There is not enough room in this questionnaire to explain my frustration with the sexual identity movement groups. I have advised employers on employment law matters for 28 years and not once during that time have I perceived either discrimination based upon sexual identity, or seen a value in identifying it in the work setting.
