<u>Personal story</u> - Please briefly describe a situation where you had to stand alone for what you thought was right when the momentum was pushing the other way. What was the result?

Craig Florian	Several years ago, we were facing serious financial issues in regard to funding and upkeep of our City swimming pool, when it was located between 3rd and 4th street along Elm Street. There was a big push to come up with funding to keep it running. Ron Bergeron, the proprietor of the "Playhouse" in Northern Mills County offered us a \$3,000 donation, which we desperately needed. The rest of the City Council at the time voted to not accept the money, but I alone voted to keep the money. Many of the opposition cited moral reasons for not accepting the funding. But I believed that my Bible said to "Love thy neighbor as thyself" and "to treat others how you would want to be treated." I felt he should be treated like any other pool donor, despite the fact he runs a business that some may not approve of. Later, I met with Mr. Bergeron personally and he signed a \$3,000 check that was accepted by the Council. We soon chose to help fund the "Welcome to Glenwood" sign located on the South end of town. Some have said that that sign was built with stripper money, which would be a true statement. And in the words of Paul Harvey, "Now you know the rest of the story."

So far, serving Glenwood as a City Councilman has been a learning adventure to say the least. In that time, I have been involved in the completion of the Mills County YMCA, the successful 28E agreement between the City of Glenwood and Glenwood Schools to build a state of the art High School on what was once City Soccer fields. We were able to convert the vacant Latter Day Saint's Church on the square to bring four separate entities under one roof: City Hall, GMU, Chamber and the Police Department. This cut down on upkeep and expense for three different facilities. We got about \$300,000 back from the public auctions of two properties. Yes, it did cost about ½ million to get it done, but it's currently insured for over a million. Doubling the taxpayer's investment? That's what I call good politics and it's what I believe in. "For the Good of Glenwood". No matter how hard it may be.

Currently, Glenwood is building an impressive water park on the east side of town. It was not an easy road, but we're getting it done for our kids and their kids. We were able to get the South corridor replaced from the post office all the way down to the South Hazel Bridge entrance on South Locust on down to the School Bus Barn. And we have done it with relatively little increase in taxes over the past 30 years. In the next four years I hope to Focus on the Future. When I first got here, I believed that one person can make a difference. I still believe that, or I wouldn't be here today.
