Priorities - What order of priority would you place on dealing with which issues facing the city?

Darcey Butts	My first priority would to place the needs of Glenwood before the wants. Also to maintain the infrastructure of our city.
Jessie Lundvall	As a mayor of Glenwood, my first priority is maintaining a balanced budget. We have to be able to operate with in our parameters of tax dollars. With that in mind-we also need to make sure that our employees who oversee the budget and financial operations of the city are knowable and well experienced in their department. That being said, my second priority would be the expansion of Glenwood's tax base. We have an Urban Revitalization and Urban Renewal Program that was created to attract new businesses as well as assist existing businesses. These programs along with the new Highway 34 corridor give our community great opportunities to grow and be attractive to new businesses. My third priority is developing an ordinance to maintain Glenwood's integrity through creating a standard for rental properties. This would assure that rental properties did not become substandard and hinder its surrounding properties valuations.

Eminent Domain - Describe your thinking on eminent domain and private property rights.

Darcey Butts	Eminent domain should not be used to make "shopping malls" etc. Its purpose should be for things like public highways.
Jessie Lundvall	I feel people should be given the option to sell their property to the government, rather than it be mandated to be sold. I feel that this option also allows for a fair price to be agreed upon. My Great Grandfather was affected by Eminent Domain during the development of Highway 34 and the Highway 275 overpass, south of Glenwood. His farm land was used to develop that area. Although we could not imagine life without those passage ways, he struggled to get the fair amount from the government and was later compensated for the state's underestimation of the land's worth.

Personal story - Please briefly describe a situation where you had to stand alone for what you thought was right when the momentum was pushing the other way. What was the result?

Darcey Butts	I refused to deliver substandard quality feed products for a feed mill I worked at and lost my job as a result.
Jessie Lundvall	When I ran for City Council, my mother asked me why I was running. I told her that I wanted people to have a voice and I wanted to make a difference in the community that I love and want my children to love. I wanted to be apart of making something great for years to come. I wanted to show the citizens that it doesn't take being wealthy or having social status to give back to a community that has given me so much. Since being on council, I have had no problem questioning projects and proposals. I refused to vote for the pool's design and estimation—the 45 page document was given to us during the meeting. I, nor the other council members had had a chance to review its contents. I was against the vine street project and the special assessment for the property owners on that street. I was able to work with two other council members to join me, we worked out a plan with our financial advisory specialist. We passed the project with no special assessment for those property owners. I also demanded higher levels of accountability from our City Administrator, I researched Iowa Code and found a written law where financial information was to be submitted to Council by a certain date. This was adopted as practice and this has helped our city with solving its financial deficiencies.

Jessie Lundvall	When making a difficult decision, I ask citizens what they want. I ask my 87 year old grandmother who lives on a fixed income. I ask myself, who is a middle class citizen. I meditate/ pray. I listen when people tell me their thoughts. I educate them on lost details and they educate me on how my decision will affect their life. As an elected official, I am a liaison, not a dictator. I acknowledge the same people who elected me, can change that in the next election. It's very important for me to be their voice and advocate at city hall.

I wish mothers who are making the decision to have an abortion would think of adoption as an option and that the gift of life is really a gift. It's not given to everyone--let adoption be considered.
