_	I require more information on this topic before I can take any stance on this issue. I have grave concerns about how our services are or could be limited to this population of individuals, particularly when said services are aimed to benefit children living in our community. I would like to enter a dialogue with knowledgeable individuals working and/or living within this delicate issue. I feel strongly that this is an issue best left to our state legislature.
	Eminent domain is only to be used in the most dire of instances and I am a strong proponent of private ownership of property (see my comments on initiatives to encourage property ownership amongst young families and low income folks). While it is true that a large bundle of rights comes along with property ownership, there is also a 'bundle of responsibilities" that is not often discussed in the law. Landlords have responsibilities to their lessees to keep the spaces rented in livable conditions and all property owners have responsibilities to their neighbors to not create situations which may be deemed a nuisance. But, in instances where a family is struggling in all aspects and financial penalization would exacerbate the problem, then I support an approach of teaching self-reliance through education about home ownership and accompanying responsibilities would address the core issues.

I support the Charter Amendment because I hold that the utmost transparency seen government and its citizens is the only way a government can best serve the needs of its people. The optics of Councilmembers holding acts with the City of Lincoln are terrible and invite Lincolnites to form distrust in our local government. Councilmembers are like the Board of tors to the City and thus, should avoid conflicts of interest at all turns. As an attorney, this issue is black and white for me - I would never advise int serving on the board of a corporation to form a contract that he or she would financially gain from.

Yes, politics are always involved, but they should not be the driving force behind the City's next steps/missteps. I will disagree with a proposal or decision when it conflicts with my core beliefs and what I know about my community, and I will compromise when doing so is in the best interests of the majority of Lincolnites. If all City elected officials do the same, we will have Lincoln on a very positive trajectory. As a councilwoman I will aim to have open, honest conversations with the executive branch of our city government as well as with my fellow councilmembers and constituents, which is the best approach to achieving success for our city as a whole.

With that being said, quoting to a specific religious text in order to support one's argument for a course of action as an elected official is completely inappropriate and may border on unconstitutional if it is the main motivation for proposing some course of action. Religious affiliation and spiritual practices are very personal and individualized, so while they are instructive to a person's moral compass, religious texts should not be offered as evidence in support of or against any governmental act. 18 DOM		The legal irregularity stems from the act itself, not the failure of the Department of Justice to uphold DOMA. The matter is before the Supreme Court of the United States and is a federal issue. With that being said, this statute has caused a plethora of issues for same-sex couples and their families. Again, I would emphasize the need to maintain equality and fairness for all of our friends, family, neighbors, colleagues and Lincolnites. The Defense of Marriage Act, if nothing else, is an administrative nightmare that I have struggled to navigate in my legal practice. The end effect of DOMA in Nebraska is that same-sex marriages perfected in other states cannot be undone in Nebraska, which means that same sex marriages now have the most permanence within our state. This causes couples with irreconcilable differences consternation, as they lose their ability to form meaningful relationships in the future that may be recognized legally in other states. And, on the opposite end of the argument, I doubt it was the State of Nebraska's intention to elevate same sex marriages to our most protected relationships, since the state also has a Constitutional Amendment stating that marriage is to be between one man and one woman.

Personally, at this point in my life, I do not think I could undergo an abortion. However, that's me. I can't begin to understand what some women are going through or how their pregnancies came into being, so I do not feel as though it is my place to impose what my course of action would be upon other women. Women should be able to make that choice individually, based on their own set of circumstances. The criminal justice system is not failsafe. Thus, we learn all the time that inmates on death row should be exonerated due to the discovery of new evidence, particularly DNA evidence. Perhaps my biggest concern with the death penalty is that the State creates the job of "professional killer" when it hires someone to perform the lethal injection. In one of my anthropology courses in college we examined the psychological effects an "executioner" undergoes and it concerns me that the State would put someone in that position. Further, I do not think the death penalty prevents future acts as it does not serve as a deterrent to other criminals. It is an expensive proposition for the State to take on and our tax dollars could be used in other ways - perhaps providing rehabilitation and services to at-risk folks and previous offenders.
